



All of Greater Pike Community Foundation's invested assets are in a single commingled pool. The invested assets in the pool are managed by Mercer Investments using diversified low-cost fixed-income and equity mutual funds, primarily index funds but some actively managed funds as well. Mercer Investments acts as co-fiduciary with Greater Pike on the portfolio. Greater Pike's investment strategy is designed to maximize returns while limiting risk with a long-term (5-10 year) investment horizon.



**Austin Prey Memorial Fund** – Created in memory of 23-year old Austin Prey to establish a local Fishing Derby event as Austin was an avid fisherman.

**Barbara J. Buchanan Fund** – Supports an annual mini-grant program that funds local nonprofit community organizations in the arts and culture, basic human needs, health, families, education, and the environment.

**Davis R. Chant Fund for the Arts** – Created to continue the giving legacy of Davis R. Chant and Chant Realtors, which includes support for festivals in Milford, PA.

**Edson D. Mosher, Jr. Fund** – Supports various local causes addressing food insecurity, health and welfare and children, as well as the St. Jude Children's Research Hospital.

**Edward and Gertrude Schneider Memorial Fund** – Supports the Milford Enhancement Committee, which works to make Milford a better place to live, visit, and do business.

I Care About Autism Fund – Established for the support of the charitable, scientific, or educational purposes of Pike Autism Support Services (PASS) and its affiliated agencies.

**John Duke and Joan Schneider Family Fund** – Created by John "Duke" and Joan Schneider to provide meaningful support for causes and charities recommended by the donors.

Kontizas Fund – Supports arts and culture, animal welfare, public safety, and emergency services, environmental stewardship/education, child victims of domestic violence, and specifically Karen Ann Quinlan Hospice and Good Shepherd Episcopal Church in Milford, PA.

Milford Enhancement Committee Endowment Fund – Established for the exclusive benefit of the Milford Enhancement Committee with the purpose to preserve and enhance Milford, Pennsylvania's invaluable heritage and special character for the benefit of residents, businesses, and visitors alike.

**O'Neil Family Fund** – Created by Charles and Celeste O'Neil to support various local causes and organizations including historic preservation in Milford, PA, autism support services and food insecurity in the Greater Pike area and elsewhere as recommended by the donors.

**Pedranti Family Charitable Fund** – Supports community enhancement, health and welfare, medical research and education, historic preservation, arts and culture with an emphasis on the Greater Pike area.

**Peter and Kathy Maio Fund** – Supports environmental issues as well as organizations addressing housing and food insecurity in the Greater Pike area and elsewhere as recommended by the donors.

**Promise of a Better Future Fund** – Established as an endowment fund to support the charitable or educational purposes of Family Promise of the Poconos, Inc.

**Ralph F. Berry Memorial Fund** – Supports charities of the donor advisor's choice in memory of Ralph Berry and the causes he held near to his heart during his lifetime.

**Richard L. Snyder Chair of Conservation Studies Fund** – Established to honor the memory of Richard L. Snyder, a community benefactor and great conservationist, this fund will provide a yearly stipend to the Delaware Valley School District to create and maintain a Richard L. Snyder Chair of Conservation Studies.

**Richard L. Snyder Fund** – Supports an annual open grant program which funds nonprofit organizations conducting work in the following areas: maintaining and enhancing the public areas of the Borough of Milford; sponsorship of local arts, culture, festivals, and events; and medical research in the fields of multiple sclerosis, HIV, LGBT issues and domestic violence.

**Richard Rhodes River Rescue Fund** – Income from the "RRRR" fund is allocated to the National Canoe Safety Patrol for the purchase of equipment, training, and other necessary items to fulfill their mission to provide rescue and assistance, as well as safety education.

**Safe Haven Legacy Fund** – Established by Safe Haven of Pike County, Inc. to provide grant awards to nonprofit organizations in Pike County helping victims of domestic violence and sexual assault find and relocate to permanent (as opposed to emergency) safe housing.

**Shuttleworth Fund** – Created to support various local causes and organizations in the Greater Pike area and elsewhere as recommended by the donor.

**Thomas and Jean Hoff Fund** – Established to primarily benefit the community of Pike County, PA, specifically the Pike County Public Library.

\*Turano Family Fund – Established to support organizations that provide opportunities for advancement of youth, including but not limited to arts, education, literacy, cultural enrichment, recreation, childhood illness, and advocacy related to the support, wellbeing, and rights of children and young people. Funding is also available to organizations that provide support to survivors of domestic violence through counseling, relocation assistance, and/or legal fees.

Walt Edwards Ashenfelter Fund for Performing Arts – Established in memory of Walt Edwards Ashenfelter to support the musical entertainment in Milford that Walt loved.

**William and Deborah Hookway Fund** – Supports various local charitable entities in the Sussex County, NJ, area and elsewhere, as recommended by the Donors. Charities and causes include but are not limited to the Sussex County YMCA and animal welfare organizations.

**Xavisean Fund** – Designed to promote civic engagement, historic preservation, social justice, healthcare, and cultural endeavors in the Greater Pike region.

Greater Pike Community Foundation has established 43 funds. There are 16 donor advised funds, three donor designated funds, five field of interest funds, 10 organizational funds, and nine scholarship funds.

Donors can establish a named fund with an initial tax-deductible gift of as little as \$1,000.

**Designated Funds:** This type of fund provides you with a wonderful way to give back to one or more specific nonprofit organizations. Distributions will be made to the organization(s) you designate.

**Donor Advised Funds:** Charitable grants from these funds are made to a variety of nonprofit organizations, which can change each year. You make tax-deductible charitable contributions immediately, without having to identify nonprofit beneficiaries right away.

**Endowment Funds:** The object of an endowment fund is to sustain a nonprofit into the future with an income stream through unstable times. Any size nonprofit organization can establish an endowment fund at Greater Pike using an endowment gift from a donor or a portion of an organization's funds.

**Field of Interest Funds:** Grants are made to organizations in a specific area of community interest to support a broad charitable goal, such as improving education, the region's cultural life or eliminating hunger.

**Organizational Funds:** Any nonprofit can benefit from this type of fund in which Greater Pike will assist with administering an endowment for long term profit that will give the organization a strategy to fulfill its mission in perpetuity.

**Scholarship Funds:** These funds are established to assist students with their education and career goals. You can create a scholarship as a memorial to someone, specifying eligibility criteria, and the grant can support any area of academic need, including tuition, books or dorm expenses.

With all funds, the donor is credited with a tax-deductible charitable contribution, without having to immediately identify the nonprofit beneficiaries. # Establish your Donor Advised Fund at Greater Pike Community Foundation

#### Benefits include:

- The flexibility to easily support causes you care about.
- You can give cash, stock, bonds, and/or other assets to a donor advised fund and receive a tax deduction when the contribution is made.
- You can request a specific dollar amount be sent to a specific charitable organization.
- Whether you decide to disburse the assets to an approved charity at the time you make the contribution or let the assets grow tax-free, you still receive a tax benefit immediately.



Greater Pike now has nine scholarship funds. The Charlie & Allyson Gillinder Scholarship Fund, new in 2024, will award one scholarship annually to a student planning to pursue a four-year degree in engineering or physics, or a world language teaching degree. This follows last year's addition of the Edson and Barbara Whitney International Studies Scholarship Fund for students pursuing a career in international studies or related fields.

In 2024, the Foundation awarded 13 area students with scholarships totaling \$59,068, including recurring awards to three past recipients who are continuing their college studies. The awards, which go to seniors from Delaware Valley, Wallenpaupack and Kittatinny high schools, come from a variety of scholarship funds administered by Greater Pike.



## **Pre-K Scholarships**

The Center for Developmental Disabilities of Pike County (CDD) was awarded \$13,248 in scholarship funding from Greater Pike Community Foundation to cover summer pre-K costs for 10 children.

The Educational Improvement Tax Credit (EITC) Program for Pre-Kindergarten Scholarship Organizations enables full or partial tuition scholarships for local children attending summer or school-year programs at eligible nonprofit pre-kindergarten scholarship organizations.

Funds are administered through a partnership among Greater Pike Community Foundation, the PA Department of Community and Economic Development (DCED), and eligible, approved businesses that receive tax credits for contributions. In 2024, contributions to Greater Pike enabling these scholarships came from Highmark Blue Cross Blue Shield, UGI Utilities, Wayne Bank, and The Dime Bank.
